DSL reviews concern and makes a decision about next steps

Decision made to discuss the concern informally with parents/carers

Decision made to refer the concern to social care

Decision made to monitor the concern

Class teacher asked to monitor student and feedback to the DSL within an agreed timescale and record on CPOMS

Monitor

Once discussed with parents, DSL decides to discuss further with parents, monitor or make a referral

If student has known SW, then discussion directly will happen
